BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. (A) As used in this section:	7
(1) "Eligible offense" means an offense under any of the	8
following Revised Code sections if the offense, an essential	9
element of the offense, the basis of the charge, or any	10
underlying offense did not involve alcohol, a drug of abuse,	11
combination thereof, or a deadly weapon: 2151.354, 2152.19,	12
2152.21, 2907.24, 2913.02, 4507.20, 4509.101, 4509.17, 4509.24,	13
4509.40, 4510.037, 4510.05, 4510.06, 4510.15, 4510.22, 4510.23,	14
4510.31, 4510.32, 4511.203, 4511.205, 4511.251, 4511.75,	15

4549.02, 4549.021, and 5743.99.	16	
(2) "Deadly weapon" has the same meaning as in section	17	
2923.11 of the Revised Code.	18

(4) "Complete amnesty" means a waiver of reinstatement	21

(5) "Driver's license or permit" does not include a	23

(6) "Indigent" means a person who is a participant in the	25	
supplemental nutrition assistance program administered by the	26	
department of job and family services pursuant to section	27	
5101.54 of the Revised Code.	28	
(B) Not later than ninety days after the effective date of	29	
this section, the Registrar of Motor Vehicles shall establish a	30 31	
driver's license reinstatement fee debt reduction and amnesty		
program. The program shall immediately terminate six months	32	
after that effective date.	33	
(C) During the period the program is in operation, both of	34	
the following apply:	35	
(1) A person whose driver's license or permit has been	36	
suspended as a result of an eligible offense may apply to the	37	
Registrar for driver's license reinstatement fee debt reduction	38	
if the person has completed all court-ordered sanctions related	39	
to the eligible offense other than the payment of reinstatement	40	
fees and at least eighteen months have expired since the end of	41	
the period of suspension ordered by the court.	42	
(2) A person whose driver's license or permit has been	43

suspended as a result of an eligible offense may apply to the	44
Registrar for complete amnesty if the person has completed all	45
court-ordered sanctions related to the eligible offense other	46
than the payment of reinstatement fees, and the person is	47
indigent and can demonstrate proof of indigence by providing	48
documentation in a form approved by the Registrar.	49
(D)(1) The Registrar shall grant reinstatement fee debt	50
reduction to a person who is eligible under division (C)(1) of	51
this section as follows:	52
(a) If the person owes reinstatement fees for multiple	53
eligible offenses, the person shall be required to pay either	54
the lowest reinstatement fee owed for those offenses or ten per	55
cent of the total amount owed for those offenses, whichever	56
amount is greater.	57
(b) If the person owes reinstatement fees for one eligible	58
offense, the person shall be required to pay one-half of the	
reinstatement fee owed for that offense.	60
(2) The Registrar shall grant complete amnesty to a person	61
eligible under division (C)(2) of this section.	62
(E) The Registrar shall conduct a public service	63
announcement regarding the driver's license reinstatement fee	64
debt reduction and amnesty program that includes a description	65
of the program and its requirements. In addition, the Registrar	66
shall make such information available on the Bureau of Motor	67
Vehicle's web site.	68
(F) The Registrar may establish any requirements and	69
procedures necessary to administer and implement this section.	70
