**A BILL**

To amend section 3313.471 of the Revised Code 1  
regarding the presentation of career information 2  
to students. 3

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 3313.471 of the Revised Code be 4  
amended to read as follows: 5

**Sec. 3313.471.** (A) As used in this section, "armed forces" 6  
means the Ohio national guard, the Ohio naval militia, the Ohio 7  
military reserve, and the active and reserve components of the 8  
United States army, navy, air force, marine corps, and coast 9  
guard. 10

(B) No school district board of education shall impose any 11  
restriction on the presentation of career information to 12

students that is not uniformly imposed on representatives of the 13  
armed forces, skilled trades, institutions of higher education, 14  
business, industry, charitable institutions, and other 15  
employers, ~~and institutions of higher education~~ or prohibit the 16  
presentation of information or recruitment of students by those 17  
representatives for employment, employment training, or 18  
education on the district's campus. The board shall provide 19  
equal access to any of the district's employment or placement 20  
services to all of the entities described in this division. 21

(C) The district board shall provide any entity described 22  
in division (B) of this section with at least two opportunities 23  
per school year to present information in person to all students 24  
in grades nine through twelve individually or in a group setting 25  
and shall provide students with the opportunity to speak in 26  
person with the entities that participate in those 27  
opportunities. This requirement may be satisfied by providing 28  
common area access for presentation of information materials or 29  
by providing a scheduled educational or career fair. 30

(D) To the extent permitted by federal law and in 31  
accordance with this section, the district board may develop an 32  
application process for entities that wish to access school 33  
property for the purpose of presenting information to students. 34  
The board may develop standards of conduct and require entities 35  
to adhere to those standards as a condition of continued access 36  
and presentation of information materials. 37

**Section 2.** That existing section 3313.471 of the Revised 38  
Code is hereby repealed. 39
