BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. All items in this section are hereby 3
appropriated as designated out of any moneys in the state 4
treasury to the credit of the designated fund. For all 5
appropriations made in this act, those in the first column are 6
for fiscal year 2016 and those in the second column are for 7
fiscal year 2017. The appropriations made in this act are in 8
addition to any other appropriations made for the FY 2016-FY 9
2017 biennium. 10

Section 2. Section 3. All items in this section are hereby appropriated as designated out of any moneys in the state treasury to the credit of the designated fund. For all appropriations made in this act, those in the first column are for fiscal year 2018 and those in the second column are for fiscal year 2019. The appropriations made in this act are in addition to any other appropriations made for the FY 2018-FY 2019 biennium.
