The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Kick was selected to preside under the Rule.

### INTRODUCTION OF BILLS

The following bills were introduced:

# H. B. No. 1 - Representatives Sykes, Manning.

To amend sections 109.42, 2151.23, 2919.27, and 3113.33 and to enact section 3113.311 of the Revised Code to authorize the issuance of dating violence protection orders with respect to conduct directed at a petitioner alleging dating violence, to provide access to domestic violence shelters for victims of dating violence, and to require the Attorney General's victim's bill of rights pamphlet to include a notice that a petitioner alleging dating violence has the right to petition for a civil protection order.

To amend sections 2315.18, 4112.01, 4112.02, 4112.04, 4112.05, 4112.051, 4112.08, and 4112.99; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 4112.051 (4112.055) and 4112.052 (4112.056); to enact new sections 4112.051, 4112.052 and sections 4112.053 and 4112.054; and to repeal section 4112.14 of the Revised Code to modify Ohio civil rights laws related to employment.

To enact sections 117.432, 117.58, 149.60, 149.61, and 3375.03 of the Revised Code to create the DataOhio Board, to specify requirements for posting public records online, to require the Auditor of State to adopt rules regarding a uniform accounting system for public offices, to establish an online catalog of public data at data.Ohio.gov, to establish the Local Government Information Exchange Grant Program, and to make appropriations.

# H. B. No. 4 - Representatives Cupp, Rogers.

Cosponsors: Representatives Becker, Butler, Carfagna, Dever, Faber, Gavarone, Ginter, Goodman, Hambley, Hill, Johnson, G., Riedel, Schaffer, Scherer, Slaby, Stein, Young.

To amend sections 2925.03 and 2925.11 of the Revised Code to provide that in determining the amount of cocaine for trafficking and possession offenses, it also includes a compound, mixture, preparation, or substance containing cocaine, and to declare an emergency.

# H. B. No. 5 - Representatives Pelanda, Gavarone.

To enact section 166.50 of the Revised Code to create a statutory definition of "microbusiness."

# H. B. No. 6 - Representative Barnes.

To enact section 2927.22 of the Revised Code to prohibit a person who publishes or disseminates criminal record information from soliciting or accepting a fee to remove, correct, modify, or refrain from publishing or otherwise disseminating the information and to provide criminal and civil remedies for a violation of the prohibition.

### **H. B. No. 7 -** Representative Cupp.

To amend sections 2305.113, 2305.252, 2305.51, 2317.421, 2317.43, and 2323.41 and to enact sections 2305.2311, 2317.44, 2317.45, 2323.40, and 2323.451 of the Revised Code to grant qualified civil immunity to certain medical providers who provide emergency medical services as a result of a disaster; to provide that certain communications made regarding an unanticipated outcome of medical care, the development or implementation of standards under federal laws, and an insurer's reimbursement policies on health care are inadmissible as evidence in a medical claim; to provide that medical bills itemizing charges are inadmissible as evidence and an amount accepted as full payment for medical services is admissible as evidence of the reasonableness of the charges; to specify the manner of sending a notice of intent to file a medical claim and provide a procedure for the discovery of other potential claims within a specified period after the filing of a medical claim; to provide that any loss of a chance of recovery or survival by itself is not an injury, death, or loss for which damages may be recovered; to provide civil immunity to certain medical providers regarding the discharge of a patient with a mental condition that threatens the safety of the patient or others; to require that governmental agencies that receive peer review committee records maintain their confidentiality; and to clarify the definition of "medical claim"

To amend section 149.43 of the Revised Code to exempt from the Public Records Law certain information concerning a minor that is included in a record related to a traffic accident involving a school vehicle in which the minor was an occupant at the time of the accident.

To amend section 4511.132 of the Revised Code to specify that the alternative protocol for proceeding into an intersection with malfunctioning traffic lights due to a failure of a vehicle detector applies only to bicycles.

To amend sections 1707.03, 1724.02, 4582.06, and 4582.31 and to enact sections 1707.05, 1707.051, 1707.052, 1707.053, 1707.054, 1707.055, 1707.056, 1707.057, and 1707.058 of the Revised Code to permit intrastate equity crowdfunding under certain circumstances.

# H. B. No. 11 - Representative Scherer.

To amend section 5701.11 of the Revised Code to expressly incorporate changes in the Internal Revenue Code since February 14, 2016, into Ohio law.

# H. B. No. 12 - Representative Gonzales.

To enact section 5.074 of the Revised Code to designate the barn as the official historical architectural structure of the state.

To amend section 2313.14 of the Revised Code to permit a prospective juror who is a mother who is breast-feeding her baby to be excused from jury service.

certain government and school databases be automatically registered to vote or have their registrations updated automatically unless those persons decline and to expand how a voter may register or update their registration through the online voter registration system.

To amend sections 1513.37, 1561.24, and 5727.81 of the Revised Code to credit a portion of the revenue derived from the kilowatt-hour tax to the Abandoned Mine Reclamation Fund, the Acid Mine Drainage Abatement and Treatment Fund, and the Mine Safety Fund and to make other changes to the use of money in those funds.

To enact section 5534.74 of the Revised Code to designate a portion of State Route 43 in Jefferson County as the "Army Corporal Carl H. Bernhart Memorial Highway."

To amend sections 2915.08 and 2915.09 of the Revised Code to reduce the licensing fee for charitable organizations conducting instant bingo on five or fewer days per year, and to allow those organizations to change the location and date of the instant bingo sessions after a license has been issued.
