**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 64** - Representatives Schuring, Reece.

To amend sections 2953.51, 2953.52, 2953.53, 2953.54, 2953.55, and 2953.61 of the Revised Code to provide for the expungement of official

records related to the apprehension, arrest, criminal charging, or trial of a person based on mistaken identity.

**H. B. No. 65** - Representative Hill.

Cosponsors: Representatives Koehler, Seitz, Cera, Duffey, Blessing, DeVitis, Ryan, Hambley, Carfagna, Brenner, Miller, Kick.

To enact section 3717.042 of the Revised Code to require the Director of Agriculture and the Director of Health to adopt rules governing reviews of registered sanitarians and sanitarians-in-training who conduct inspections of retail food establishments and food service operations.

**H. B. No. 66** - Representative Young.

To amend section 3345.45 and to enact section 3345.451 of the Revised Code to require permanently tenured state university or college faculty members to teach at least three credit hours of undergraduate courses per semester.

**H. B. No. 67** - Representative Young.

To amend sections 1337.53, 2323.12, and 2323.13 and to repeal sections 1907.09 and 2323.14 of the Revised Code to prohibit a person from obtaining a confession of judgment from another person except in connection with the settlement of a dispute.

**H. B. No. 68** - Representative Anielski.

Cosponsors: Representatives Becker, Vitale, Riedel, Greenspan, Scherer, Blessing, Dean, Lipps, Ashford, Sprague, Boccieri, Fedor, Leland, Rogers, Sweeney.

To amend sections 2903.33, 2903.34, 2907.08, 2907.321, 2907.322, 2907.323, and 2929.13 of the Revised Code to include an impaired person as a potential victim of voyeurism, to include conduct involving an impaired person within the offenses of pandering obscenity involving a minor, pandering sexually oriented matter involving a minor, and illegal use of a minor in a nudity-oriented material or performance, and to prohibit an owner, operator, administrator, or employee of a care facility from creating, sharing, reproducing, or publishing any image of a care facility resident without a proper purpose and without prior written consent from the resident.

**H. B. No. 69** - Representative Cupp.

Cosponsors: Representatives Blessing, Dever, Hambley, Hill, Faber, Seitz.

To amend section 5709.40 of the Revised Code to require reimbursement of certain township fire and emergency medical service levy revenue forgone because of the creation of a municipal tax increment financing district.

**H. B. No. 70** - Representative Merrin.

Cosponsors: Representatives DeVitis, Goodman, Dean, Riedel, Hood, Keller,

Brinkman, Roegner, Vitale, Becker, Sheehy, Wiggam, Thompson, Retherford, Koehler, Householder, Henne, Stein, Butler, LaTourette.

To enact section 5735.50 of the Revised Code to enact the "Fuel Tax Transparency Act" requiring stickers to be placed on retail service station pumps displaying the rates of federal and state taxes applicable to gasoline and diesel fuel.
