The House met pursuant to adjournment.

### INTRODUCTION OF BILLS

**"Section 3. This act is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety. The reason for such necessity is to enable taxpayers to avoid making**

miscellaneous adjustments on their 2016 tax returns that increase tax liabilities. Therefore, this act shall go into immediate effect."
