INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 148 - Representative Patmon.

Cosponsor: Representative Young.

To amend sections 109.572, 715.27, 3781.102, 4740.01, 4776.01, and 4776.20 and to enact sections 4785.01, 4785.02, 4785.021, 4785.03, 4785.04, 4785.05, 4785.06, 4785.07, 4785.08, 4785.09, 4785.11, 4785.12, 4785.13, 4785.14, 4785.15, 4785.16, 4785.17, 4785.18, 4785.19, 4785.20, 4785.21, and 4785.99 of the Revised Code to require statewide registration of home improvement contractors, to create the Home Improvement Board, and to make an appropriation.

H. B. No. 149 - Representatives Patmon, Conditt.

Cosponsors: Representatives Antani, Becker, Brinkman, Dean, Ginter, Goodman, Hambley, Henne, Hill, Hood, Huffman, Keller, Koehler, LaTourette, McColley, Riedel, Roegner, Romanchuk, Slaby, Smith, R., Thompson, Faber, Sprague.

To amend sections 2108.18 and 2919.14 of the Revised Code to expand the crime of abortion trafficking and to increase the penalty.

H. B. No. 150 - Representative Patmon.

To enact section 4503.441 of the Revised Code to create a special license plate for hearing-impaired individuals.

H. B. No. 151 - Representative Patmon.

To enact section 2923.26 of the Revised Code to prohibit a transfer of a firearm from a person who is not a federally licensed firearms dealer to a person who is not a federally licensed firearms dealer unless it is done through a federally licensed firearms dealer, through a state or local law enforcement agency, or pursuant to a specified exception; to require that background checks be conducted when a firearm is transferred through a federally licensed firearms dealer or a state or local law enforcement agency; and to provide for recordkeeping with respect to information obtained pursuant to such a background check.

H. B. No. 152 - Representative Patmon.

To amend section 1533.13 of the Revised Code to require an applicant for a hunting license to specify whether the applicant has been convicted of or pleaded guilty to a felony and to require the license to specify "firearm restricted" if an applicant has so indicated.

H. B. No. 153 - Representative Patmon.

To enact sections 2923.51, 2923.52, 2923.53, 2923.54, and 2923.55 of the Revised Code to generally ban the manufacture, sale, alteration, and public display of imitation firearms and the disguising of a firearm to make it resemble an imitation firearm.

H. B. No. 154 - Representatives Smith, R., Manning.

To amend sections 3333.38 and 3345.32 and to enact section 3333.125 of the Revised Code to establish the Commercial Truck Driver Student Aid program and to make an appropriation.
