INTRODUCTION OF BILLS

To amend section 122.17 of the Revised Code to provide that compensation paid to certain home-based employees may be counted for purposes of an employer qualifying for and complying with the terms of a Job Creation Tax Credit.

To amend sections 2301.02 and 2301.03 of the Revised Code to add two judges to the Domestic Relations Division of the Franklin County Court of Common Pleas to be elected in 2018.

To amend sections 303.21 and 519.21 and to enact section 901.60 of the Revised Code to allow an owner of residential property to keep, harbor, breed, or maintain small livestock on the property, and to prohibit zoning authorities from regulating certain agricultural activities conducted on residential property for noncommercial purposes.
