The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 182** - Representative Seitz.

Cosponsors: Representatives Dever, Brinkman, Lipps.

To amend section 4710.01 and to enact section 4710.05 of the Revised Code regarding debt adjusting.

**H. B. No. 183** - Representative Perales.

Cosponsors: Representatives Butler, Sweeney, Craig, Hambley, Bocchieri, Riedel, Lipps, Rezabek, Seitz, O'Brien.

To enact section 4561.02 of the Revised Code to establish the Governing Board of the Ohio Aviation Hall of Fame and Learning Center for purposes of establishing the Hall and inducting persons into it.

**H. B. No. 184** - Representatives Gavarone, DeVitis.

To amend sections 1739.05, 2925.01, 4715.03, 4715.09, 4715.10, 4715.11, 4715.13, 4715.14, 4715.22, 4715.36, 4715.39, and 4715.64 and to enact sections 1751.90, 3333.614, 3923.90, 4715.43, 4715.431, 4715.432, 4715.433, 4715.434, 4715.435, 4715.436, 4715.437, and 5164.951 of the Revised Code to authorize the provision of dental services through teledentistry, to require a proposal for creation of a primary care dental student component of the Choose Ohio First Scholarship Program, and to make other changes to the laws governing the practices of dentistry and dental hygiene.

**H. B. No. 185** - Representative Hambley.

Cosponsors: Representatives Becker, Riedel, Young, Bishoff, Smith, K.

To amend section 5747.29 of the Revised Code to expand the scope of political contributions that qualify for the income tax credit for contributions to political campaigns to candidates for any state, county, municipal, or district office.

Said bills were considered the first time.
