The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 203** - Representative Barnes.

To enact section 122.043 of the Revised Code to require the Director of Development Services to establish a youth summer jobs pledging initiative to increase access to summer employment opportunities for high school and college youth.

**H. B. No. 204** - Representative Barnes.

To amend sections 121.02 and 121.03 and to enact section 121.77 of the Revised Code to create the Department of Grants and Philanthropic Gestures.

**H. B. No. 205** - Representative Barnes.

To amend sections 323.25, 5721.18, and 5721.31 of the Revised Code to enact the "Senior Housing Relief Act" to prohibit the sale of delinquent property tax certificates for homesteads owned for at least 20 years by a person aged 65 or older at the time of the sale and to prohibit tax foreclosure on such property when the senior homeowner has paid the current taxes in all but five or fewer taxable years.

**H. B. No. 206** - Representative Barnes.

To enact section 4561.61 of the Revised Code to create the Commercial Airline and Air Freight Commission.

**H. B. No. 207** - Representative Patton.

To amend sections 4511.092 and 4511.093 of the Revised Code to prohibit a municipal corporation or township that does not operate either a fire department or an emergency medical services organization from utilizing traffic law photo-monitoring devices.

**H. B. No. 208** - Representative Patton.

To amend section 4511.093 of the Revised Code to prohibit a local authority with a population of 200 or fewer from utilizing traffic law photo-monitoring devices.

**H. B. No. 209** - Representative Patton.

To amend section 4511.093 of the Revised Code to prohibit a local authority, in any year, from issuing a total number of traffic tickets based on the use of traffic law photo-monitoring devices that exceeds two times the population of the local authority.

**H. B. No. 210** - Representative Patton.

To amend section 4511.093 of the Revised Code to prohibit a local authority from deriving more than 30 per cent of the total annual revenue of the local authority from the issuance of tickets for traffic law violations based on evidence recorded by traffic law photo-monitoring devices.

**H. B. No. 211** - Representative Hughes.

Cosponsors: Representatives Antani, Edwards, Leland, Cera, Boccieri, Clyde, Smith, K.

To amend sections 109.572, 121.08, 2925.01, 4745.01, 4776.10, and 4776.20 and to enact sections 4764.01 to 4764.20 and 4764.99 of the Revised Code to require the licensure of home inspectors and to create the Ohio Home Inspector Board to regulate the licensure and performance of home inspectors.

**H. B. No. 212** - Representative Householder.

To enact section 5534.801 of the Revised Code to designate a portion of State Route 16 in Coshocton County as the "Staff Sergeant Paul C. Mardis Jr. Memorial Highway."

**H. B. No. 213** - Representative Dever.

To amend sections 109.572, 121.08, 4763.01, 4763.02, 4763.03, 4763.05, 4763.08, 4763.11, 4763.12, 4763.13, 4763.14, 4763.15, 4763.17, and 4763.19 and to enact sections 4768.01, 4768.02, 4768.03, 4768.04, 4768.05, 4768.06, 4768.07, 4768.08, 4768.09, 4768.10, 4768.11, 4768.12, 4768.13, 4768.14, 4768.15, and 4768.99 of the Revised Code to change the definition of "appraisal" for purposes of the Real Estate Appraiser Licensing Law, to make changes to certain procedures and the exceptions to licensure under that law, to regulate appraisal management companies, and to declare an emergency.

**H. B. No. 214** - Representatives LaTourette, Merrin.

To amend section 3701.79 and to enact sections 2919.10 and 2919.101 of the Revised Code to prohibit a person from performing, inducing, or attempting to perform or induce an abortion on a pregnant woman who is seeking the abortion because an unborn child has or may have Down Syndrome.

**H. B. No. 215** - Representative Riedel.

To amend sections 1901.01, 1901.02, 1901.03, 1901.07, 1901.08, 1901.31, 1901.312, 1901.34, and 1907.11 of the Revised Code to create the Paulding County Municipal Court in Paulding on January 1, 2019, to establish one full-time judgeship in that court, to provide for the nomination of the judge by petition only, to abolish the Paulding County County Court on that date, to designate the Paulding County Clerk of Courts as the clerk of the Paulding County Municipal Court, and to provide for the election for the Paulding County Municipal Court of one full-time judge in 2018.
