**INTRODUCTION OF BILLS**

To enact sections 2307.48, 2307.481, 2307.482, and 2919.10 of the Revised Code to criminalize impeding access to reproductive health care and to create a cause of action for harassment or intimidation of one or more employees of a health care facility.
