INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 240 - Representative Barnes.

To enact sections 5.236 and 3345.43 of the Revised Code to enact the "Respect Your Date Act" to designate the month of April as "Respect Your Date Month" and to require each state institution of higher education to adopt a policy regarding dating violence, domestic violence, sexual assault, stalking, and rape on campus and to declare an emergency.

H. B. No. 241 - Representative Barnes.

To amend section 3701.99 and to enact sections 3701.36 to 3701.366 of the Revised Code to establish the Ohio Diabetes Registry.

H. B. No. 242 - Representative Carfagna.

To amend sections 3309.374 and 3309.661 of the Revised Code regarding School Employees Retirement System annual cost-of-living adjustments.

H. B. No. 243 - Representatives Patterson, Cera.

Cosponsors: Representatives Lepore-Hagan, Boggs, Antani, O'Brien, West, Miller, Boccieri.

To amend sections 131.51 and 5739.02 and to enact sections 5739.212 and 5741.033 of the Revised Code to exempt from sales and use taxation the bulk sale of firewood and certain other heating fuels, and to reimburse the Local Government Fund and Public Library Fund and county and transit sales tax collections for the resulting revenue losses.

H. B. No. 244 - Representative Patterson.

Cosponsors: Representatives Ramos, Sykes, Thompson, Kent, Antani, Antonio, Dever, Boyd, Patton, Gavarone, Sheehy, Sweeney, Boccieri, Slaby, Roegner, Smith, K., Arndt, Miller, Lepore-Hagan, Ashford, Boggs, LaTourette, O'Brien, Sprague.

To enact section 5.236 of the Revised Code to designate the month of June as "Alzheimer's and Brain Awareness Month."

H. B. No. 245 - Representatives Boccieri, Lepore-Hagan.

To enact sections 4113.87, 4113.88, 4113.89, 4113.90, 4113.91, and 4113.92 of the Revised Code to enact the Consumer Protection Call Center Act of 2017 to require the Department of Job and Family Services to compile a list of all employers that relocate a call center to a foreign country and to disqualify employers on that list from state grants, loans, and other benefits.

H. B. No. 246 - Representatives Boccieri, Rezabek.

Cosponsors: Representatives Lepore-Hagan, Stein, O'Brien, Riedel, Miller, West, Strahorn, Ashford, Sheehy, Brenner.

To enact section 3318.80 of the Revised Code to require the Ohio School Facilities Commission to provide funding to certain county boards of developmental disabilities to assist in the acquisition of classroom facilities.

H. B. No. 247 - Representative Romanchuk.

To amend sections 4928.01, 4928.04, 4928.05, 4928.06, 4928.14, 4928.141, 4928.142, 4928.144, 4928.17, 4928.18, 4928.20, 4928.23,

4928.231, 4928.232, 4928.31, 4928.34, 4928.35, 4928.542, and 4933.81; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 4928.04 (4928.041); to enact new section 4928.04 and sections 4903.191, 4928.28, 4928.281, 4928.29, and 4928.30; and to repeal section 4928.143 of the Revised Code to require refunds to utility customers who have been improperly charged, to eliminate electric security plans and require all electric standard service offers to be delivered through market-rate offers, and to strengthen corporate separation requirements.

In line 4 of the title, after "taxes" insert "and to reimburse the Local Government Fund, the Public Library Fund, counties, and transit authorities for the resulting revenue losses"

After line 61, insert:

"Section 2. (A) On or before the seventh day of each month, beginning in September 2017 and ending in July 2018, the Director of Budget and Management shall credit both to the Local Government Fund and to the Public Library Fund an amount from the General Revenue Fund equal to the difference obtained by subtracting the total tax revenue credited to the General Revenue Fund during the preceding month, as determined under section 131.51 of the Revised Code, from the amount of such revenue the Tax Commissioner estimates would have been credited to the General Revenue Fund during that month if Section 1 of S.B. 9 of the 132nd General Assembly had not been enacted.

(B) On or before the forty-fifth day after the end of each month, beginning with August 2017 and ending with May 2018, the Director of Budget and Management shall pay from the General Revenue Fund to the county treasurer of a county or fiscal officer of a transit authority levying a tax or taxes pursuant to section 5739.021, 5739.023, 5739.026, 5741.021, 5741.022, or 5741.023 of the Revised Code an amount equal to the difference obtained by subtracting (a) the aggregate amount of payments provided to the county treasurer or fiscal officer under division (D) of section 5739.21 and division (B) of section 5741.03 of the Revised Code for that month from (b) the aggregate amount the Tax Commissioner estimates would have been payable to that county treasurer or fiscal officer under those divisions for that month if Section 1 of S.B. 9 of the 132nd General Assembly had not been enacted. A payment received by a county treasurer or fiscal officer under this division shall be credited as would revenue from such tax or taxes levied by the county or transit authority as required under section 5739.211 or 5741.031 of the Revised Code proportionately according to the ratio the rate of each such tax levied by the county or transit authority bears to the total rate of all such taxes levied thereby."
