The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Antani was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 272** - Representatives Householder, Kick.

Cosponsors: Representatives Hambley, Riedel, Becker, Roegner, Vitale, Bocchieri, Goodman, Retherford, Stein, Brinkman, Kent, Antani, Rezabek, Schaffer, Lipps, Hood, Wiggam, Hill, Greenspan, Romanchuk.

To amend sections 1533.10, 1533.11, 1533.111, 1533.112, 1533.12, 1533.32, and 1533.81 of the Revised Code to allow a landowner's grandchildren of any age to hunt or fish on the landowner's property without obtaining a hunting license, deer permit, wild turkey permit, fur taker permit, fishing license, or waterfowl hunting permit, and to allow certain partially disabled veterans to receive a free license, permit, or wetlands habitat stamp.

**H. B. No. 273** - Representative Gavarone.

Cosponsor: Representative Johnson.

To amend sections 3702.30, 3727.05, 4731.14, 4731.281, 4731.29, 4731.56, and 4731.57 and to enact sections 3727.061, 3901.89, and 5164.302 of the Revised Code to prohibit a physician from being required to secure a maintenance of certification as a condition of obtaining licensure, reimbursement, or employment or obtaining admitting privileges or surgical privileges at a hospital or health care facility.

**H. B. No. 274** - Representative Clyde.

Cosponsors: Representatives Fedor, Leland, Ingram, Boyd, Bocchieri, Miller, Sykes, Galonski, West, O'Brien, Sheehy.

To amend sections 3501.05 and 3503.21 of the Revised Code to modify the circumstances under which a voter registration may be canceled.

**H. B. No. 275** - Representative Slaby.

To enact section 5534.152 of the Revised Code to designate the bridge spanning the Tuscarawas River, that is part of State Route 93 in Canal Fulton, as the "Lance Corporal Michael Stangelo, USMC, Memorial Bridge."

**H. B. No. 276** - Representatives Rezabek, Greenspan.

Cosponsors: Representatives Hambley, Perales, Henne, Huffman, Koehler, Lipps, Antani.

To amend section 2903.21 of the Revised Code to expand the offense of aggravated menacing to prohibit threatening a utility worker with intent to obstruct the operation of a utility.

**H. B. No. 277** - Representative Seitz.

To amend section 2505.09 and to enact section 3301.132 of the Revised Code to stay the execution of certain judgments in favor of the Department of Education during the appeals process.

Said bills were considered the first time.
