The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 301** - Representative Butler.

Cosponsors: Representatives Becker, Dean, Faber, Goodman, Retherford, Riedel, Seitz, Sprague.

To enact section 9.05 of the Revised Code to require the approval of the General Assembly for a state agency to agree to a consent decree or court-approved settlement agreement that would alter or prohibit the enforcement of a law of this state.

**H. B. No. 302** - Representatives Boggs, Antonio.

Cosponsors: Representatives Ramos, Carfagna, Ashford, Howse, Smith, K., Lepore-Hagan, Kent, Kelly, Miller.

To enact section 3701.36 of the Revised Code to authorize a pregnant minor to consent to receive health care to maintain or improve her life or the life of the unborn child she is carrying.

**H. B. No. 303** - Representatives Lipps, Kelly.

Cosponsors: Representatives Ingram, LaTourette, Smith, K., Dean, Brenner, Lepore-Hagan, Kent, Boggs, Sweeney, Miller, Schaffer, Holmes, Carfagna, Fedor, Dever.

To amend sections 955.011, 955.99, 4112.01, 4112.04, 4112.05, and 4112.99, to enact section 4112.025, and to repeal section 955.43 of the Revised Code to prohibit places of public accommodation from preventing the use of a service animal.

Said bills were considered the first time.
