The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 329** - Representative Pelanda.

To amend sections 1333.91, 1333.92, and 1333.93 of the Revised Code to modify the law governing pyramid promotional schemes.

**H. B. No. 330** - Representative Rogers.

Cosponsors: Representatives Ashford, Boggs, Celebrezze, Craig, Kelly, Kent, Lepore-Hagan, Miller, Patton, Ramos, Riedel, Romanchuk, Scherer, Smith, K., Sweeney, West.

To enact section 5534.494 of the Revised Code to designate a portion of State Route 91 in Willoughby as the "Patrolman Jason Gresko Memorial Highway."

**H. B. No. 331** - Representative Ingram.

To amend section 5502.12 of the Revised Code to prohibit the use of information obtained from an accident report by any person for commercial solicitation purposes.

**H. B. No. 332** - Representative Antani.

Cosponsors: Representatives Leland, West, Ingram, Kent, Keller, Lipps, Zeltwanger, Vitale, Romanchuk, Riedel, Becker.

To enact sections 2108.36, 2108.37, and 2108.38 of the Revised Code regarding anatomical gifts, transplantation, and discrimination on the basis of disability.

**H. B. No. 333** - Representatives Becker, Leland.

Cosponsors: Representatives Vitale, Retherford, Keller, Duffey, Thompson, Brinkman, Hambley, Henne, Dean, Roegner, Hood, Riedel, Goodman, Schaffer, Butler, Wiggam, Koehler, Slaby, Conditt, Brenner, Sweeney, Boggs, Zeltwanger, Miller, Young.

To amend section 5747.08 of the Revised Code to allow married couples to

elect to file either separate state tax returns or a joint state return, irrespective of their federal filing status.

**H. B. No. 334** - Representative Scherer.

To amend section 5733.40 of the Revised Code to provide that wages and guaranteed payments paid by a professional employer organization to the owner of a pass-through entity that has contracted with the organization may be considered business income.

Said bills were considered the first time.
