**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 335** - Representatives Lepore-Hagan, Howse.

Cosponsors: Representatives Antonio, Boccieri, Ingram, Kent, Riedel, Smith, K., Sykes, West, Young.

To enact section 5.2516 of the Revised Code to designate April as "Sarcoidosis Awareness Month."

**H. B. No. 336** - Representatives Barnes, Greenspan.

To amend sections 2151.354, 2152.19, 2152.21, 4507.1614, 4509.101, 4510.037, 4510.05, 4510.06, 4510.10, 4510.22, 4510.31, and 4510.32 of the Revised Code to prohibit the imposition of driver's license and temporary instruction permit reinstatement fees in specified circumstances and to name this act the Reinstatement Fee Amnesty Initiative.

Said bills were considered the first time.
