To amend sections 109.73, 955.11, 955.12, 955.22, 955.222, 955.44, 955.54, and 955.99 and to enact sections 955.13, 955.223, 955.224, 955.225, and 955.60 of the Revised Code to revise provisions of the Dogs Law governing nuisance, dangerous, and vicious dogs, to revise enforcement of that Law, and to establish a notification process regarding complaints of certain violations of that Law.

To amend sections 1901.01, 1901.02, 1901.03, 1901.07, 1901.08, 1901.312, 1901.34, and 1907.11 of the Revised Code to create the Paulding County Municipal Court in Paulding on January 1, 2020, to establish one full-time judgeship in that court, to provide for the nomination of the judge by petition only, to abolish the Paulding County County Court on that date, and to provide for the election for the Paulding County Municipal Court of one full-time judge in 2019, was taken up for consideration the third time.

To amend sections 5739.01 and 5739.02 of the Revised Code to exempt prescription eyeglasses, contact lenses, and other optical aids sold by licensed dispensers from sales and use tax beginning July 2019, was taken up for consideration the third time.

Representative Rogers moved to amend, amendment 0570, as follows:

In line 1 of the title, after "sections" insert "131.51,"; after "5739.01" insert a comma

In line 5 of the title, after "2019" insert ", and to reimburse the Local Government Fund and Public Library Fund for the resulting revenue losses"

In line 6, after "sections" insert "131.51, "; after "5739.01" insert a comma

Between lines 7 and 8, insert:

**"Sec. 131.51.** (A) On or before July 5, 2013, the tax commissioner shall compute the following amounts and certify those amounts to the director of budget and management:

(1) A percentage calculated by multiplying one hundred by the quotient obtained by dividing the total amount credited to the local government fund in fiscal year 2013 by the total amount of tax revenue credited to the general revenue fund in fiscal year 2013. The percentage shall be rounded to the nearest one-hundredth of one per cent.

(2) A percentage calculated by multiplying one hundred by the quotient obtained by dividing the total amount credited to the public library fund in fiscal year 2013 by the total amount of tax revenue credited to the general revenue fund in fiscal year 2013. The percentage shall be rounded to the nearest one-hundredth of one per cent.

(B) On or before the seventh day of each month, the director of budget and management shall credit to the local government fund an amount equal to the product obtained by multiplying the percentage calculated under division (A)(1) of this section by the sum of the total tax revenue credited to the general revenue fund during the preceding month plus the H.B. 116 supplemental distribution. In determining the total tax revenue credited to the general revenue fund during the preceding month, the director shall include amounts transferred from the fund during the preceding month under this division and division (C) of this section. Money shall be distributed from the local government fund as required under section 5747.50 of the Revised



Code during the same month in which it is credited to the fund.

(C) On or before the seventh day of each month, the director of budget and management shall credit to the public library fund an amount equal to the product obtained by multiplying the percentage calculated under division (A)(2) of this section by the sum of the total tax revenue credited to the general revenue fund during the preceding month plus the H.B. 116 supplemental distribution. In determining the total tax revenue credited to the general revenue fund during the preceding month, the director shall include amounts transferred from the fund during the preceding month under this division and division (B) of this section. Money shall be distributed from the public library fund as required under section 5747.47 of the Revised Code during the same month in which it is credited to the fund.

(D) The director of budget and management shall develop a schedule identifying the specific tax revenue sources to be used to make the monthly transfers required under divisions (B) and (C) of this section. The director may, from time to time, revise the schedule as the director considers necessary.

(E) As used in this section, "H.B. 116 supplemental distribution" means the difference obtained by subtracting the total tax revenue credited to the general revenue fund during the preceding month from the amount of such revenue the commissioner estimates would have been credited to that fund during that month if sections 131.51, 5739.01, and 5739.02 of the Revised Code had not been amended by H.B. 116 of the 132nd general assembly."
