## EIGHTY-FIFTH DAY

The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 356** - Representative Young.

To amend sections 1531.13, 1533.342, and 1533.343 and to enact section 1533.344 of the Revised Code to amend the laws concerning commercial netting in Lake Erie.

**H. B. No. 357** - Representatives Miller, Boggs.

Cosponsor: Representative Hughes.

To amend section 4501.21 and to enact section 4503.909 of the Revised Code to create the "Grandview Heights Schools" license plate.

**H. B. No. 358** - Representative Arndt.

To enact section 5534.631 of the Revised Code to designate a portion of State Route 19 in Ottawa County as the "Sgt. Jordan Marshall Memorial Highway."

**H. B. No. 359** - Representative Stein.

Cosponsors: Representatives Blessing, Boccieri, Faber, Galonski, Ginter, Green, Hambley, Johnson, Lang, LaTourette, Riedel, Romanchuk, Scherer, Smith, K., West.

To enact section 5.015 of the Revised Code to create a suggested ceremonial procedure for retiring an Ohio state flag.

**H. B. No. 360** - Representative Greenspan.

To amend sections 2903.31, 3313.66, 3313.661, 3313.666, 3314.03, and 3326.11 and to enact sections 3313.669 and 3345.19 of the Revised Code to enact the "Ohio Anti-Bullying and Hazing Act" with regard to school discipline and bullying and hazing policies at public schools and public colleges.

**H. B. No. 361** - Representative Greenspan.

To amend section 5715.19 of the Revised Code to increase the time within which boards of revision must decide property tax complaints.

**H. B. No. 362** - Representatives Carfagna, Ramos.

To amend sections 5505.16, 5505.162, 5505.17, 5505.174, 5505.18, and 5505.59 of the Revised Code to revise the law governing the State Highway Patrol Retirement System.

**H. B. No. 363** - Representatives Goodman, Brenner.

To amend sections 3345.02, 3345.021, 3345.023, and 3345.21, to amend, for the purpose of adopting a new section number as indicated in parentheses, section 3345.025 (3345.0210), and to enact new section 3345.025 and sections 3345.024 and 3345.026 of the Revised Code to enact the "Campus Free Speech Act" with respect to the freedom of speech and assembly at state institutions of higher education and the charging and allocation of student activity fees.

**H. B. No. 364** - Representative Clyde.

To enact section 5.22106 of the Revised Code to designate the fourth Tuesday of September as "Ohio Voter Registration Day."
