The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 384 - Representative Gonzales.

Cosponsor: Representative Becker.

To amend sections 4505.101, 4513.601, and 4513.611 of the Revised Code to require only one notice to be sent to a vehicle owner and any known lienholder after a vehicle is towed from a private tow-away zone.

H. B. No. 385 - Representative West.

Cosponsors: Representatives Smith, K., Howse, Ashford, Sheehy, Kent, Craig.

To enact sections 124.16 and 124.161 of the Revised Code to prohibit a state agency from preventing an employee from discussing the employee's own wages or another employee's wages, to prohibit a state agency from seeking a prospective employee's wage or salary history, to prohibit retaliation against an employee who discusses wages or opposes a prohibited act or practice, and to create the Wage Disparity Study Committee.

Said bills were considered the first time.
