In line 8, after "sections" insert "9.69,"; after "2307.82" insert a comma

Between lines 9 and 10, insert:

**"Sec. 9.69. (A) As used in this section:**

**(1) "E-verify program" means the employment verification program as jointly administered by the United States department of homeland security and the social security administration under 8 U.S.C. 1324a, or any of its successor programs.**

(2) "Employer" means a person that is an employer for federal income tax purposes.

(3) "Tax incentive" means a tax deduction, exemption, deferral, exclusion, allowance, credit, reimbursement, or preferential tax rate that exempts, either in whole or in part, certain persons, income, goods, services, or property from the effect of taxes levied by the state.

(B) An employer that is awarded or receives a tax incentive on or after the effective date of this section shall do all of the following:

(1) Register with a federal status verification system such as the e-verify program;

(2) Verify the identity and legal working status of each employee hired by the employer after the tax incentive is awarded or received;

(3) Keep a record of that verification for the duration of the employee's employment with the employer or three years, whichever is longer.

(C) An employer subject to the requirements of division (B) of this section shall attest by sworn affidavit signed before a notary that the employer is in compliance with such requirements and shall provide documentation of the employer's enrollment in the federal status verification system. The employer shall submit the affidavit and documentation to the department of taxation within thirty days after being awarded or first receiving the tax incentive.

(D)(1) Whoever knowingly makes a false statement under division (C) of this section or who fails to provide any information required by that division is ineligible for any future tax incentive.

(2) The tax commissioner may issue an assessment against any person that makes a false statement under division (C) of this section or who fails to provide any information required by that division for the amount of the tax incentive received by the person. The assessment shall be issued under the chapter of the Revised Code applicable to the tax for which the tax incentive was awarded or received, but without regard to any limitation on the time within which an assessment may be issued under that chapter."
