The House met pursuant to adjournment.

Representative Brenner was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 459 - Representative Henne.

Cosponsors: Representatives Hambley, Becker, Romanchuk, Seitz, Kick, Hood.

To amend section 1739.02 and to enact section 4123.354 of the Revised Code to allow groups of employers to be granted status as a self-insuring employer for purposes of the Workers' Compensation Law.

H. B. No. 460 - Representatives Patterson, Sheehy.

Cosponsors: Representatives Antonio, Smith, K., Kelly, O'Brien, West.

To amend sections 321.24, 5715.27, and 5717.02 and to enact sections 1515.12 and 5709.30 of the Revised Code to exempt qualifying riparian buffers in the Western Basin of Lake Erie from property taxation, to reimburse local taxing units for resulting revenue losses, and to require soil and water conservation districts to assist landowners with the creation and maintenance of riparian buffers.

H. B. No. 461 - Representatives Fedor, Galonski.

Cosponsors: Representatives Romanchuk, Antonio, Howse, Riedel, Smith, K., Hambley, Cera, Kent, Lepore-Hagan, Miller, Clyde, West, O'Brien, Kelly, Sheehy, Boggs, Carfagna, Scherer, Patterson, Boyd, Celebrezze, Strahorn, Sykes, Ingram, Boccieri, Leland, Sweeney, Rogers.

To amend sections 2152.021, 2905.32, and 2929.01 of the Revised Code to require a juvenile court to hold a delinquency complaint in abeyance if the court has reason to believe that the act charged might be prostitution related or that the child might be a victim of human trafficking and to provide that the same elements for the offense of trafficking in persons that apply to a victim under the age of sixteen also apply to a victim who is age sixteen or seventeen.

Said bills were considered the first time.
