Voting equipment acquired under this section shall be distributed by the Director, in consultation with the Secretary of State, to county boards of elections.

As used in this section, "voter marked and voter verified paper ballot" means a paper ballot on which the voter records the voter's choices, either by hand or by use of a marking device that records the voter's choices on a paper ballot that the voter then must inspect for accuracy." In line 948, delete "\$90,800,000" and insert "\$208,800,000"
