INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 561 - Representatives Boggs, Lanese.

To amend sections 2907.02, 2907.03, 2907.04, 2907.05, 2907.06, 2907.07, and 2945.42 of the Revised Code to eliminate the spousal exceptions for the offenses of rape, sexual battery, unlawful sexual conduct with a minor, gross sexual imposition, sexual imposition, and importuning and to permit a person to testify against the person's spouse in a prosecution for any of those offenses.

H. B. No. 562 - Representative Leland.

To amend section 1509.06 of the Revised Code to prohibit the drilling of a horizontal well in various state and local parks.

H. B. No. 563 - Representative West.

Cosponsors: Representatives Brown, Ingram, Ashford, Fedor, Smith, K., Howse.

To amend section 2923.25 of the Revised Code to prohibit a federally licensed firearms dealer from transferring a firearm while a background check is pending unless 30 days have elapsed.

H. B. No. 564 - Representative West.

Cosponsors: Representatives Brown, Fedor, Ashford, Smith, K., Howse, Kent.

To amend section 2923.25 of the Revised Code to require a 72-hour waiting period between the purchase and delivery of firearms and to impose a fine for violating this requirement.

H. B. No. 565 - Representatives Hood, Vitale.

To amend sections 9.04, 109.572, 149.43, 2151.414, 2151.421, 2305.11, 2305.234, 2307.52, 2307.53, 2307.54, 2317.56, 2505.02, 2901.01, 2903.09, 2919.11, 2919.122, 2919.17, 2919.191, 2919.193, 2919.201, 2919.24,

2919.25, 2925.11, 2935.36, 2950.03, 2953.25, 2967.193, 3301.32, 3301.541, 3301.88, 3319.31, 3319.39, 3701.034, 3701.046, 3701.511, 3702.30, 3901.87, 4112.01, 4729.291, 4729.292, 4731.22, 4731.223, 4731.224, 4731.225, 4731.25, 4731.281, 4731.293, 4731.91, 5101.55, 5103.0319, 5119.367, and 5153.111; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 2919.122 (2919.12) and 2919.191 (2919.19); to enact section 2317.57; and to repeal sections 9.041, 2151.85, 2305.114, 2317.561, 2505.073, 2919.12, 2919.121, 2919.123, 2919.13, 2919.151, 2919.16, 2919.171, 2919.18, 2919.19, 2919.192, 2919.20, 2919.202, 2919.203, 2919.204, 2919.205, 3701.341, 3701.79, 3701.791, 3727.60, 5101.56, and 5101.57 of the Revised Code regarding the abolition of abortion in the state of Ohio and the protection of unborn humans.

H. B. No. 566 - Representatives Scherer, Cera.

To amend sections 1333.11, 1333.12, and 1333.15 and to enact section 1333.13 of the Revised Code regarding cigarette minimum pricing.

Said bills were considered the first time.
