The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Ryan was selected to preside under the Rule.

The journal of yesterday was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 567** - Representative Fedor.

Cosponsors: Representatives Lepore-Hagan, Antonio, West, Brown.

To amend section 3923.48 and to enact section 3923.461 of the Revised Code to impose limitations on long-term care premium rate increases.

**H. B. No. 568** - Representative Butler.

Cosponsors: Representatives DeVitis, Merrin, Riedel.

To amend sections 2152.02, 2152.10, 2152.12, 2935.26, and 4511.181 and to enact section 4511.199 of the Revised Code to authorize a law enforcement officer to arrest a driver of a motor vehicle if the officer has probable cause to believe that the driver committed a moving violation and that the moving violation was a contributing factor in a motor vehicle accident that caused serious physical harm to or the death of another person, to authorize the officer to request a warrant to conduct a chemical test to determine whether the driver was under the influence of drugs or alcohol if there is probable cause to do so, to authorize the officer to order the administration of a chemical test under specified circumstances, to require the mandatory bindover (for trial as an adult rather than a juvenile) of a 16- or 17- year-old who is alleged to have committed aggravated vehicular homicide, and to designate this act as "Sophie's Law."

Said bills were considered the first time.

### REPORTS OF STANDING AND SELECT COMMITTEES AND BILLS FOR SECOND CONSIDERATION

Representative Clyde submitted the following report:

The standing committee on Government Accountability and Oversight to which was referred **H. B. No. 345**-Representative Butler, et. al., having had the same under consideration, reports it back with the following amendment and recommends its passage when so amended.

## RE: AWARD PRIZES FOR CURING DISEASES

Representative Blessing moved to amend as follows:

In line 362, after "5." insert, "Recognizing that the goal of the compact is to pool the potential savings of as many states and countries as possible to generate sufficient financial incentive to develop a cure for many of the world's most devastating diseases, the compact will respect the laws of each of these United States by adopting rules that establish ethical standards for research that shall be followed in order for a prize to be claimed. The compact, in the rules, shall establish a common set of ethical standards that embodies the laws and restrictions in each of the states so that to be eligible for claiming a prize the entity submitting a cure must not have violated any of the ethical standards in any one of the fifty states, whether the states have joined the compact or not. The compact will publish these common ethical standards along with the specific criteria for a cure for each of the diseases the compact has targeted.

So long as a researcher follows the common ethical standards in effect at the time the research is done, an entity presenting a cure will be deemed to have followed the standards. On or before January 1 of each year, the compact shall review all state laws to determine if additional ethical standards have been enacted by any of the fifty states and the federal government. Any changes to the common ethical standards rules based on new state laws shall be adopted and published by the compact, but shall not take effect in cure criteria for a period of three years to allow for sufficient notice to researchers.
