Sub. H.B. 49 of the 132nd General Assembly have (A) caused sales tax collections to decrease in counties in which lower sales tax rates relative

to other counties apply during the period of each such exemption relative to other periods, and (B) caused sales tax collections to increase in counties in which higher sales tax rates relative to other counties apply during the period of each such exemption relative to other periods. In particular, the report shall analyze sales tax collections for counties described in division (A) of this section and such collections for counties described in division (B) of this section that adjoin such counties.
