The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Pelanda was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills and joint resolution were introduced:

H. B. No. 622 - Representative Perales.

Cosponsors: Representatives Butler, Henne, Kick, Merrin, Retherford, Rezabek, Riedel, Romanchuk, Thompson, Young.

To amend sections 2503.45, 2923.123, and 2923.126 of the Revised Code to generally authorize a judge or magistrate who is a concealed handgun licensee to possess a concealed handgun in a courthouse or attached parking area, to expand the exemption from the offenses regarding illegal conveyance, possession, or control of a deadly weapon or dangerous ordnance into or in a courthouse for a judge or magistrate who is a licensee with respect to a concealed handgun, and to require a specified secure storage of the concealed handgun while in the courthouse as a condition for application of the authorization and exemption.

H. B. No. 623 - Representatives Gonzales, Carfagna.

To enact section 5534.403 of the Revised Code to designate a portion of Interstate Route 270 in Franklin County as the "Officers Anthony Morelli and Eric Joering Memorial Highway."

H. B. No. 624 - Representative Kent.

To enact section 4112.33 of the Revised Code to establish the New African Immigrants Grant and Gift Fund in the state treasury.

H. B. No. 625 - Representatives Lang, Lipps.

Cosponsors: Representatives Carfagna, Riedel, Roegner, Thompson.

To amend sections 504.04, 715.013, 3736.01, and 3767.32 and to enact sections 301.30 and 3736.021 of the Revised Code to authorize a person to use an auxiliary container for any purpose, to prohibit a municipal corporation, charter county, or limited home rule township from imposing a tax or fee on auxiliary containers, and to clarify that the existing anti-littering law applies to auxiliary containers.

H. B. No. 626 - Representatives Smith, K., Fedor.

Cosponsors: Representatives Antonio, West, Ingram, Sykes, Lang, Ashford.

To enact section 3302.101 of the Revised Code to establish a moratorium on the creation of new academic distress commissions.

H. B. No. 627 - Representatives Smith, K., Galonski.

Cosponsors: Representatives Leland, Antonio, Ramos, Rogers, Brown, Howse, Boggs, O'Brien, Strahorn, West.

To amend sections 2901.13 and 2933.82 of the Revised Code to eliminate the period of limitation for the criminal prosecution of a person for rape.

H. B. No. 628 - Representatives Stein, Retherford.

Cosponsors: Representatives Koehler, Riedel, Brenner, Becker, Slaby.

To amend section 3319.22 of the Revised Code with regard to qualifications for obtaining a resident educator license.

H. J. R. No. 15 - Representatives Fedor, West.

Cosponsors: Representatives Antonio, Boggs, Smith, K., Kelly, Lepore-Hagan, Ramos.

Proposing to enact Section 7 of Article VI of the Constitution of the State of Ohio to require a universal preschool education program that is free and available to any four- or five-year-old child who resides in the state.

Said bills and joint resolution were considered the first time.
