# ONE HUNDRED SIXTY-FIRST DAY Hall of the House of Representatives, Columbus, Ohio Thursday, May 3, 2018, 9:00 o'clock a.m.

The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

## H. B. No. 629 - Representative Antani.

To amend sections 102.02, 102.03, 3517.13, and 3517.992 of the Revised Code to modify the law governing gifts and travel reimbursements to members of the General Assembly and to prohibit the use of campaign contributions for travel outside the United States.

### H. B. No. 630 - Representative Galonski.

To amend Section 733.67 of Am. Sub. H.B. 49 of the 132nd General Assembly and to amend for the purpose of codifying and changing the number of Section 733.67 of Am. Sub. H.B. 49 of the 132nd General Assembly to section 3313.617 of the Revised Code to extend the alternative graduation requirements for two additional years.

# H. B. No. 631 - Representatives Hughes, Patterson.

To amend sections 1711.53, 1711.55, and 1711.99 and to enact section 1711.552 of the Revised Code to revise the laws governing amusement ride operation and safety, to designate this act as "Tyler's Law," and to declare an emergency.

# H. B. No. 632 - Representatives Lang, Holmes.

Cosponsors: Representatives Carfagna, Riedel, Seitz, Wiggam.

To amend sections 3905.423 and 3905.426 and to repeal section 3905.425 of the Revised Code regarding motor vehicle ancillary product protection contracts and motor vehicle service contracts.

# H. B. No. 633 - Representatives Boggs, Miller.

To amend sections 3767.32 and 3767.99 of the Revised Code to prohibit individuals who own or control private property in municipal corporations from depositing litter on that property.

# H. B. No. 634 - Representative Stein.

To enact section 5534.881 of the Revised Code to designate a portion of State Route 99 in Huron County as the "Lance Corporal James Sprowl Memorial Highway."

# H. B. No. 635 - Representative Ramos.

Cosponsors: Representatives Seitz, Patterson, Smith, K., Antonio.

To amend section 4501.21 and to enact sections 4503.516 and 4503.517 of the Revised Code to create a school license plate program.

## H. B. No. 636 - Representative Ramos.

Cosponsors: Representatives Smith, K., Perales, Antonio, Brown, Kent, Butler.

To amend section 5901.08 of the Revised Code to exempt veterans from the three-month county residency requirement to be eligible for financial assistance from the county veterans service commission, if the veteran has relocated to the county from another Ohio county, state, or United States territory after the Governor or President of the United States declares a disaster or emergency.

### H. B. No. 637 - Representative Clyde.

Cosponsors: Representatives Antonio, Brown, Miller, West, Ramos.

To amend sections 111.42, 111.44, 149.43, 3503.011, 3503.10, 3503.11, 3503.18, 3503.21, and 3503.28 and to enact sections 3301.28 and 3503.192 of the Revised Code to permit sixteen and seventeen year olds to preregister to vote.

Said bills were considered the first time.
