The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 644 - Representative Clyde.

Cosponsors: Representatives Boggs, Patterson, Ramos, Antonio, Kelly, Brown, West.

To amend sections 101.30 and 103.51 and to enact sections 103.52 and 103.53 of the Revised Code to specify public records, public meetings, and other requirements with which the Ohio Redistricting Commission, the General Assembly, and the Legislative Task Force on Redistricting and Demographic Research must comply during the redistricting process.

H. B. No. 645 - Representative Howse.

Cosponsors: Representatives Ashford, Boggs, Antonio, Sykes, Ramos, Smith, K.

To amend section 101.30 and to enact section 103.147 of the Revised Code to require the Director of the Legislative Service Commission to prepare a human impact statement concerning a bill or resolution that proposes to amend the law governing criminal justice.

H. B. No. 646 - Representatives Brown, Scherer.

Cosponsors: Representatives Sweeney, Kent, Riedel, Thompson, Smith, R., Patterson, Leland, Smith, K.

To amend sections 4510.036 and 4511.75 of the Revised Code to enhance the penalty for failing to stop for a school bus that is picking up or dropping off school children when the offender has a prior violation within a five-year period.

H. B. No. 647 - Representatives Brown, Scherer.

Cosponsors: Representatives Antonio, Holmes, West, Ingram, Celebrezze, Hill, Cera, Kent.

To enact section 1349.85 of the Revised Code to establish the Wire Fraud Information Act.

H. B. No. 648 - Representatives Brown, Scherer.

Cosponsors: Representatives Antonio, Holmes, West, Ingram, Celebrezze, Hill, Cera, Kent.

To enact sections 1182.01, 1182.02, and 1315.051 of the Revised Code to establish the Suspicious Wire Transfers Temporary Hold Act.

H. B. No. 649 - Representative Becker.

Cosponsors: Representatives Henne, Lang, Butler, Vitale, Keller, Dean.

To amend sections 101.27, 141.011, 141.04, and 4928.64 of the Revised Code to enact the "Average Wage Fully Uniform Law (AWFUL)" to set the baseline compensation for General Assembly members equal to Ohio's median household income.

H. B. No. 650 - Representative Keller.

Cosponsors: Representatives Kick, Riedel, Sheehy.

To enact section 901.61 of the Revised Code to establish the rollover protective structure grant program for eligible tractors and to repeal section 901.61 of the Revised Code on July 1, 2019, to terminate the grant program.

Said bills were considered the first time.
