RESOLVED, By the members of the House of Representatives who are affiliated with the Republican party that Shane Wilkin, Republican, having the qualifications set forth in the Ohio Constitution and the laws of Ohio to be a member of the House of Representatives from the 91st House District, is hereby elected, effective June 20, 2018, pursuant to Section 11 of Article II of the Ohio Constitution, as a member of the House of Representatives from the 91st House District, to fill the vacancy created by the unexpired portion of the term of said Clifford A. Rosenberger, ending on December 31, 2018; and be it further
