INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 715 - Representatives Schuring, West.

To amend sections 729.52 and 743.06 of the Revised Code to authorize a municipal corporation to use up to 5% of its water and sewer funds for sewerage or water system extensions in each fiscal year when the extension is for economic development purposes.

RESOLVED, By the members of the House of Representatives who are affiliated with the Republican party that Jeffrey Todd Smith, Republican, having the qualifications set forth in the Ohio Constitution and the laws of Ohio to be a member of the House of Representatives from the 43rd House District, is hereby elected, effective July 24, 2018, pursuant to Section 11 of Article II of the Ohio Constitution, as a member of the House of Representatives from the 43rd House District, to fill the vacancy created by the unexpired portion of the term of said Jeffery S. Rezabek, ending on December 31, 2018; and be it further

RESOLVED, That a copy of this resolution be spread upon the pages of the Journal of the House of Representatives together with the yeas and nays of the members of the House of Representatives affiliated with the Republican party voting on the resolution, and that the Clerk of the House of Representatives shall certify the resolution and vote on its adoption to the Secretary of State.
