Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Lanese was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 723 - Representative Holmes.

Cosponsor: Representative Ashford.

To amend section 1509.22 of the Revised Code to limit the number of injection well permits that the Chief of the Division of Oil and Gas Resources Management may issue in a county.

H. B. No. 724 - Representative Pelanda.

Cosponsors: Representatives Duffey, Antonio, Rogers.

To amend section 2505.02 and to enact sections 2323.54, 2323.541, 2323.542, and 2323.543 of the Revised Code to restrict persons designated as abusive civil action plaintiffs from filing civil actions against certain defendants without the court's permission.

H. B. No. 725 - Representatives Sykes, Boyd.

Cosponsors: Representatives Ashford, Ingram, Howse, Lepore-Hagan, Ramos, Celebrezze, Boggs, Antonio, Miller, Smith, K., Kelly, West.

To enact sections 5101.805 and 5101.806 of the Revised Code to require entities funded through the Ohio Parenting and Pregnancy Program to provide only medically accurate information.

H. B. No. 726 - Representative Gavarone.

To amend sections 1751.67, 2133.211, 2919.171, 2919.202, 3313.539, 3701.926, 3707.511, 3719.06, 3727.06, 3923.233, 3923.301, 3923.63, 3923.64, 4723.01, 4723.07, 4723.28, 4723.41, 4723.42, 4723.43, 4723.432, 4723.44, 4723.48, 4723.481, 4723.482, 4723.493, 4723.50, 4731.22, 4731.27, 4731.281, 4761.17, and 5164.07, to enact section 4731.058, and to repeal sections 4723.431 and 5164.73 of the Revised Code regarding standard care arrangements entered into by advanced practice registered nurses and collaborating physicians or podiatrists, physician prescribing of schedule II

controlled substances from convenience care clinics, and clearances by licensed health professionals of concussed student athletes.

H. B. No. 727 - Representative Schuring.

To amend sections 5747.02 and 5747.98 and to enact section 5747.74 of the Revised Code to authorize an income tax credit for investments in an Ohio Opportunity Zone.

Said bills were considered the first time.
