# REPORTS OF REFERENCE AND BILLS FOR SECOND CONSIDERATION

Senator Obhof reports for the standing committee on Rules and Reference, recommending that the following bills, standing in order for second consideration, be referred to committee as recommended:

S. B. No. 8 -Senators Gardner, Terhar, et al.

To enact section 3318.39 of the Revised Code to require the Ohio School Facilities Commission to establish a program assisting school districts in purchasing technology and making physical alterations to improve technology infrastructure and school safety and security.

To the Committee on Education.

S. B. No. 30 -Senator Eklund, et al.

To enact section 305.50 of the Revised Code to authorize counties to adopt resolutions regulating motor vehicle traffic on county and township roads.

To the Committee on Local Government, Public Safety and Veterans Affairs.

# S. B. No. 31 -Senator Eklund, et al.

To enact section 3718.026 of the Revised Code to authorize a board of county commissioners or municipal legislative authority to elect to withdraw the county or municipal corporation from the application of any rule adopted by the Department of Health after January 1, 2014, that governs the design of household sewage treatment systems.

To the Committee on Energy and Natural Resources.

#### S. B. No. 32 -Senator Eklund, et al.

To amend sections 2945.71 and 2945.73 of the Revised Code to provide a prosecutor an additional fourteen days to commence a trial after a person charged with a felony has been discharged because the person has not been brought to trial within the required amount of time and to authorize the court to release the person from detention in connection with those charges pending trial.

To the Committee on Judiciary.

**S. B. No. 33** -Senator Eklund, et al. To amend sections 2913.04 and 2923.129 and to enact section 5503.101 of the Revised Code to allow disclosure of information from the law enforcement automated data system (LEADS) to a defendant in a traffic or criminal case.

To the Committee on Judiciary.

S. B. No. 34 -Senator Manning, et al.

To amend sections 3314.03, 3317.01, 3326.11, and 3328.24 and to enact section 3313.621 of the Revised Code to generally require public and chartered nonpublic schools to open for instruction after Labor Day.

To the Committee on Education.

S. B. No. 35 -Senator Skindell, et al.

To amend sections 5747.71 and 5747.98 of the Revised Code to remove the income restriction on the earned income tax credit and to make the credit refundable beginning in 2017.

To the Committee on Ways and Means.

S. B. No. 36 -Senator Hite, et al.

To amend sections 5713.31, 5713.34, and 5715.01 of the Revised Code to require that the computation of the capitalization rate for the purposes of determining CAUV of agricultural land be computed using a method that excludes appreciation and equity buildup and to stipulate that CAUV land used for a conservation practice or enrolled in a federal land retirement or conservation program for at least three years must be valued at the lowest of the values assigned on the basis of soil type.

S. B. No. 37 -Senator Hite, et al.

To amend sections 505.49, 737.052, and 737.15 and to enact section 109.804 of the Revised Code to require the Ohio Peace Officer Training Commission to develop and conduct a chief of police training course for newly appointed village, city, and township chiefs of police.

To the Committee on Local Government, Public Safety and Veterans Affairs.

**S. B. No. 38** -Senator Yuko, et al. To amend sections 119.14, 121.083, 1349.61, 4111.02, 4111.03, 4111.09, 4111.13, 4111.14, 4113.15, 4115.03, 4121.01, 4123.01, 4123.026, 4141.01, and 5747.01 and to enact sections 4177.01, 4177.02, 4177.03, 4177.04, 4177.05, 4177.06, 4177.07, 4177.08, 4177.09, 4177.10, 4177.11, 4177.12, 4177.13, 4177.14, 4177.15, 4177.16, 4177.17, 4177.18, and 4177.99 of the Revised Code to raise the minimum wage; to eliminate the prohibition against political subdivisions establishing a different minimum wage; to raise the salary threshold above which certain employees are exempt from the overtime law; and to create a uniform standard to determine whether an individual performing services for an employer is an employee of that employer.

To amend section 5701.11 of the Revised Code to expressly incorporate changes in the Internal Revenue Code since February 14, 2016, into Ohio law, was considered the third time.

To amend sections 3302.01, 3302.03, 3302.41, 3314.03, 3314.032, 3314.08, 3314.23, 3314.27, and 3314.271 and to enact sections 3302.038, 3314.088, 3314.241, 3314.242, and 3314.52 of the Revised Code regarding community school operator contracts, the operation of Internet- and computer-based community schools, and performance metrics for blended learning schools.

S. B. No. 40 - Senators Eklund, Williams.

Cosponsors: Senators LaRose, Schiavoni, Brown, Thomas, Coley, Yuko, Terhar.

To amend sections 2929.02, 2929.022, 2929.024, 2929.03, 2929.04, 2929.06, 2953.21, and 2953.23 and to enact section 2929.025 of the Revised Code to provide that a person convicted of aggravated murder who shows that the person had a serious mental illness at the time of committing the offense cannot be sentenced to death for the offense and to provide a mechanism for resentencing to a life sentence a person previously sentenced to death who proves that the person had a serious mental illness at the time of committing the offense.

**S. B. No. 41** - Senator Eklund.

Cosponsors: Senators Schiavoni, Hoagland, Coley, Yuko.

To amend sections 2151.421, 2317.02, and 2921.22 of the Revised Code to provide generally a testimonial privilege for communications between a qualified advocate rendering advocacy services and a victim of sexual violence, menacing by stalking, or domestic violence, to exempt the nondisclosure of that privileged communication from the offense of failure to report a crime, to require a qualified advocate to report knowledge or reasonable suspicion of child abuse or neglect of the victim except for privileged communications, and to specify circumstances in which the victim is considered to have waived the privilege.

**S. B. No. 42** - Senator Eklund. Cosponsors: Senators LaRose, Gardner, Bacon, Huffman, Brown, Hoagland, Oelslager, Hite, Terhar, Peterson.

To amend sections 2925.02, 2925.03, 2925.04, 2925.05, 2925.11, 2925.12, 2925.14, 2925.141, 2925.22, 2925.23, 2925.36, 2925.51, 2929.14, 3719.99, and 4729.99 of the Revised Code to expressly provide that drug offense penalties that refer to a particular type of drug also apply to a compound, mixture, preparation, or substance containing a detectable amount of that drug and to declare an emergency.
