The Senate met pursuant to adjournment.

The journal of the last legislative day was read and approved.

The following guests were recognized by the Senate prior to the commencement of business:

Senator Gardner recognized the sixth, seventh, and eighth grade students from the Holy Family Catholic School in Cincinnati.

**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 103** - Senator Coley.

Cosponsors: Senators Williams, Brown.

To amend sections 5502.26 and 5502.261 of the Revised Code to permit a board of county commissioners, as an alternative to entering into an agreement to establish a countywide emergency management agency, to enter into a contract of not longer than four years with the county sheriff or a chief of a fire department that has countywide authority to implement a countywide emergency management program.

**S. B. No. 104** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Skindell, Brown.

To amend section 3319.46 of the Revised Code to prohibit the use of seclusion on students in public schools.

**S. B. No. 105** - Senator Tavares.

Cosponsors: Senators Eklund, Thomas, Sykes, Hite, Yuko, Schiavoni, Beagle, Williams, Brown.

To enact section 5.2315 of the Revised Code to designate the month of October as "Ohio Principals Month."

**S. B. No. 106** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Brown.

To enact section 4511.80 of the Revised Code to prohibit smoking in a motor vehicle in which a child under six years of age is a passenger.

**S. B. No. 107** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Brown, Schiavoni, Skindell, Beagle, Williams.

To amend section 4507.52 of the Revised Code to provide that any

nondriver identification card that is issued to a veteran who is disabled or blind may be issued without an expiration date.

**S. B. No. 108** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Schiavoni, Skindell, Williams, Brown.

To enact section 5.242 of the Revised Code to designate the month of June as "Pride Month."

**S. B. No. 109** - Senator Tavares.

Cosponsors: Senators Yuko, Thomas, Skindell, Brown.

To enact section 5502.59 of the Revised Code to establish the "Yellow Dot" motor vehicle medical information program within the Department of Public Safety.

**S. B. No. 110** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Skindell, Brown.

To enact sections 4715.43, 4723.94, 4725.62, 4729.71, 4730.55, 4731.33, 4732.35, 4734.58, 4743.09, 4753.17, 4755.72, 4757.47, 4758.73, 4759.13, 4760.23, 4761.19, 4762.24, 4765.60, 4773.10, 4774.23, 4778.26, and 4779.35 of the Revised Code to require a health care professional to wear identification when providing care or treatment in the presence of a patient.

**S. B. No. 111** - Senator Tavares.

Cosponsors: Senators Thomas, Yuko, Skindell, Williams.

To amend section 4511.21 of the Revised Code to require school zones to be indicated by signs equipped with flashing or other lights or that indicate the times during which the restrictive speed limit is enforced, and to make an appropriation.

**S. B. No. 112** - Senator Schiavoni.

Cosponsors: Senators Williams, Sykes, Brown, Skindell, Yuko, Tavares.

To enact section 164.11 of the Revised Code to establish the green infrastructure fund and to make an appropriation.

**S. B. No. 113** - Senator Coley.

Cosponsor: Senator Terhar.

To amend sections 4503.10, 5735.06, and 5735.10 and to enact sections 4501.50, 4503.106, and 5735.50 of the Revised Code to levy an additional registration tax on passenger cars, noncommercial motor vehicles, and commercial cars and trucks beginning on January 1, 2020; to authorize a per-gallon motor fuel retail price reduction for consumers that is equal to the state per-gallon motor fuel tax of \$.28; and to exempt each gallon of motor fuel that is sold at the reduced retail price from the state motor fuel tax.
