A prison term imposed on an offender under division (H)(3) of this section shall not be reduced pursuant to section 2929.20, section 2967.193, or any other provision of Chapter 2967, or Chapter 5120, of the Revised Code. If a prison term is imposed on an offender under division (H)(3) of this section, the offender shall serve the prison term consecutively to and prior to any prison term imposed for the underlying felony violation of section 2903.11 or 2919.22 of the Revised Code and consecutively to and prior to any other prison term or mandatory prison term previously or subsequently imposed on the offender."
