**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 129** - Senators Jordan, Tavares.

Cosponsors: Senators Sykes, Thomas, Yuko.

To amend sections 2925.01, 4709.03, 4713.01, 4713.02, 4713.07, 4713.08, 4713.081, 4713.09, 4713.10, 4713.14, 4713.16, 4713.17, 4713.24, 4713.28, 4713.31, 4713.32, 4713.34, 4713.35, 4713.36, 4713.41, 4713.44, 4713.45, 4713.55, 4713.56, 4713.58, 4713.59, 4713.60, 4713.61, 4713.62, 4713.63, 4713.64, and 4713.69, to enact new section 4713.39 and sections 4713.70, 4713.71, and 4713.72, and to repeal sections 4713.25, 4713.30, and 4713.39 of the Revised Code to make changes to the Cosmetology Licensing Law.

**S. B. No. 130** - Senator Tavares.

To amend sections 2301.02 and 2301.03 of the Revised Code to add two judges to the Domestic Relations Division of the Franklin County Court of Common Pleas to be elected in 2018.
