The following bills were introduced and considered for the first time:

S. B. No. 134 - Senator Gardner.

To enact section 5534.151 of the Revised Code to designate a portion of State Route 795 in Wood County as the "Lt Col Thomas P. Belkofer Memorial Highway."

S. B. No. 135 - Senator LaRose.

Cosponsors: Senators Eklund, Uecker, Brown, Skindell.

To make supplemental operating appropriations for the FY 2018-FY 2019 biennium and supplemental capital appropriations for the FY 2017-FY 2018 biennium to implement a voting machine and equipment acquisition program.

MESSAGE FROM THE PRESIDENT

Pursuant to Senate Rules No. 19 and 20, the President of the Senate makes the following changes to Senate standing committees:

- Remove Senator Yuko from Education; Government Oversight and Reform; Insurance and Financial Institutions; Local Government, Public Safety and Veterans Affairs; Transportation, Commerce and Workforce; and the Finance Subcommittee on Primary and Secondary Education, and replace with Senator Schiavoni.
- Remove Senator Schiavoni from Rules and Reference and the Finance Subcommittee on General Government, and replace with Senator Yuko.
- Remove Senator Tavares as the Ranking Member of Transportation, Commerce and Workforce, and replace with Senator Schiavoni as Ranking Member.
- Remove Senator Yuko as the Ranking Member of Government Oversight and Reform, and replace with Senator Schiavoni as Ranking Member.
