INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 155 - Senators Terhar, Peterson.

To amend sections 4928.01, 4928.02, 4928.141, 4928.142, and 4928.143 of the Revised Code to allow electric distribution utilities to recover costs for a national security generation resource.

S. B. No. 156 - Senators Schiavoni, Yuko.

Cosponsors: Senators Brown, Sykes, Skindell.

To enact sections 4113.87, 4113.88, 4113.89, 4113.90, 4113.91, and 4113.92 of the Revised Code to enact the Consumer Protection Call Center Act of 2017 to require the Department of Job and Family Services to compile a list of all employers that relocate a call center to a foreign country and to disqualify employers on that list from state grants, loans, and other benefits.
