**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 159** - Senator Williams.

Cosponsors: Senators Sykes, Brown, Tavares.

To amend sections 2953.51, 2953.52, and 2953.55 of the Revised Code to permit a person to apply for the sealing of the official records pertaining to a case in which the person was convicted of an offense for which the person is granted a pardon.

**S. B. No. 160** - Senator Williams.

Cosponsors: Senators Skindell, Sykes, Brown, Schiavoni, Tavares, Huffman.

To amend section 4510.10 of the Revised Code to allow a court to authorize completion of a community service program in lieu of payment of

driver's license reinstatement fees when the court determines that an offender cannot reasonably pay the fees.

**S. B. No. 161** - Senator Yuko.

Cosponsors: Senators Thomas, Brown, Skindell, Sykes.

To enact section 5534.491 of the Revised Code to designate a portion of I-271 in Cuyahoga County as the "Captain Michael Palumbo Memorial Highway."
