**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 187** - Senator Eklund.

Cosponsor: Senator Wilson.

To amend section 718.27 of the Revised Code to allow municipal corporations to charge delinquent taxpayers the costs of collecting municipal income taxes regardless of whether the costs are incurred before or after a judgment is entered against the taxpayer.

**S. B. No. 188** - Senator Hite.

Cosponsors: Senators Peterson, Manning, Gardner, Dolan, Lehner, Bacon, LaRose, Beagle, Hottinger, Hackett, Kunze, Eklund, Wilson, Schiavoni.

To amend sections 4906.20 and 4906.201 of the Revised Code to revise wind turbine setback provisions for economically significant wind farms.

**S. B. No. 189** - Senator Tavares.

Cosponsors: Senators Thomas, Sykes, Coley, Yuko.

To enact section 5534.54 of the Revised Code to designate a portion of U.S. Route 33 in Franklin County as the "Senator John W. E. Bowen III Memorial Highway."

**S. B. No. 190** - Senator Hoagland.

Cosponsors: Senators Terhar, Eklund, Lehner, Gardner, Schiavoni.

To enact section 124.1312 of the Revised Code to grant full-time state employees paid leave for the purpose of attending medical examinations and appointments provided through the United States Department of Veterans Affairs.

**S. B. No. 191** - Senator Schiavoni.

Cosponsors: Senators Lehner, Yuko, Tavares, Thomas, Williams, Sykes, Brown.

To amend sections 3302.03, 3313.813, 3314.03, 3314.18, and 3326.11 and to enact section 3313.818 of the Revised Code to establish the Breakfast After The Bell Program for public schools.

Dear Senate President Obhof:

It is my pleasure to present to you for the advice and consent of the Ohio Senate the appointment of Andra L. Troyer to the Ohio Consumers' Counsel Governing Board pursuant to Ohio Revised Code Section 4911.17.

The Ohio Consumers' Counsel Governing Board appoints the Consumers' Counsel and the Deputy Consumers' Counsel and monitors the operations of the Office of the Consumers' Counsel. The Governing Board consists of nine members, with three members each representing the following groups: organized labor; residential consumer; and, family farmers. The Revised Code requires that no more than five members of the Governing Board may be from the same political party. Andra L. Troyer is a Republican and will represent family farmers. Enclosed is her bio for your review.
