INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 203 - Senator Dolan.

Cosponsors: Senators Sykes, Eklund.

To amend sections 718.02 and 718.82 of the Revised Code to reinstate the municipal income tax "throw-back rule" used in apportioning business income among municipalities.

S. B. No. 204 - Senator Dolan.

Cosponsors: Senators Coley, Eklund, Huffman, Lehner.

To amend sections 3505.03, 3505.04, and 3513.13 of the Revised Code to require uncontested races to appear at the end of an election ballot.

S. B. No. 205 - Senator Dolan.

Cosponsors: Senators Eklund, Schiavoni.

To amend sections 1701.01, 1701.03, 1701.04, 1701.05, 1701.38, 1701.59, 1701.591, and 1701.94 and to enact section 1701.96 of the Revised Code to allow a corporation to become a benefit corporation.
