To enact section 5164.302 of the Revised Code regarding surety bonds and minimum training for certain Medicaid providers.

S. B. No. 219 - Senator Thomas.

Cosponsors: Senators Schiavoni, Sykes, Yuko, Brown, Tavares.

To amend sections 2923.13 and 2923.14 and to enact section 2923.133 of the Revised Code to prohibit certain conduct regarding trigger cranks, bumpfire devices, and other items that accelerate a semi-automatic firearm's rate of fire but do not convert it into an automatic firearm.

S. B. No. 220 - Senators Hackett, Bacon.

To enact sections 1354.01, 1354.02, 1354.03, 1354.04, and 1354.05 of the Revised Code to provide a legal safe harbor to covered entities that implement a specified cybersecurity program.
