INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 225 - Senators Schiavoni, Eklund.

Cosponsors: Senators Skindell, Yuko, Thomas, Sykes, Brown, Lehner, Williams, Hoagland, O'Brien, Tavares.

To amend section 184.10 and to enact sections 122.97, 122.971, 122.972, 122.973, 122.974, 122.975, 122.976, 122.977, and 122.978 of the Revised Code to create the Ohio Broadband Development Grant Program and to make an appropriation.

S. B. No. 226 - Senator Bacon.

Cosponsors: Senators Eklund, LaRose, Yuko, Oelslager, Manning, Hottinger, Lehner.

To amend sections 5739.02, 5739.03, and 5739.05 of the Revised Code to provide for a permanent three-day sales tax "holiday" each August during which sales of clothing and school supplies are exempt from sales and use tax.
