INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 266 - Senator Oelslager.

Cosponsor: Senator Obhof.

To amend section 164.05 of the Revised Code to make capital appropriations and changes to the law governing capital projects and to make reappropriations for the biennium ending June 30, 2020.

S. B. No. 267 - Senators Brown, Kunze.

Cosponsors: Senators Schiavoni, LaRose, Tavares.

To amend sections 2907.24 and 5101.87 of the Revised Code to increase the penalty for soliciting when the person solicited is eighteen years of age or older, to specify that the fine for soliciting in this circumstance is not more than two thousand five hundred dollars, and to specify that up to one thousand dollars of that fine may be deposited into the Victims of Human Trafficking Fund.
