### INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bill was introduced and considered for the first time:

**S. B. No. 299** - Senators Gardner, O'Brien. Cosponsors: Senators Peterson, Brown, Manning, Schiavoni, Dolan, Sykes, Hottinger.

To amend section 154.22 of the Revised Code and to amend Sections 211.10 and 211.20 of Am. Sub. H.B. 49 of the 132nd General Assembly and Sections 207.230, 207.440, 215.10, 223.10, 223.40, and 223.50 of H.B. 529 of the 132nd General Assembly, to allow equipment for the protection and preservation of Lake Erie to be purchased with proceeds from the Parks and Recreation Improvement Fund, and to appropriate funds for projects enhancing water quality in the Western Lake Erie Basin.

### **OFFERING OF RESOLUTIONS**

Senators Gardner and O'Brien offered the following joint resolution:

S. J. R. No. 6-Senators Gardner, O'Brien.

Cosponsors: Senators Manning, Brown, Schiavoni, Hottinger, LaRose.

Proposing to enact Section 2t of Article VIII of the Constitution of the State of Ohio to permit the issuance of general obligation bonds to fund clean water improvements.
