WHEREAS, Multiemployer pension plans are governed by	3
collective bargaining agreements negotiated by employers and	4
workers who choose to sacrifice higher wages and other benefits	5
in exchange for secure pension benefits; and	6
WHEREAS, The Pension Benefit Guaranty Corporation	7
Multiemployer Insurance Program insures multiemployer pension	8
plans and provides financial assistance to a plan only after the	9
plan is insolvent; the pension benefits paid out are guaranteed	10
benefits but only up to a certain legally limited amount; and	11
WHEREAS, About 130 multiemployer plans are at risk of	12
insolvency during the next 20 years, jeopardizing the pension	13
benefits of over 1 million workers, retirees, and survivors; and	14
WHEREAS, The Pension Benefit Guaranty Corporation	15
Multiemployer Insurance Program is at risk of becoming insolvent	16
by 2025 due to the increased volume and size of claims, leading	17
to a decrease in the amount of quaranteed benefits that may be	1.8

Pension Reform Act to allow insufficiently funded multiemployer	21
pension plans to reduce the pension benefits promised to	22
workers, retirees, and survivors to try to keep the plan	23
solvent; and	24
WHEREAS, The Butch Lewis Act of 2017 (S. 2147) creates the	25
Pension Rehabilitation Administration to provide loans to	26
qualified insolvent or underfunded multiemployer plans to be	27
used to pay pension benefits and invest to improve the plan's	28
financial position; now therefore be it	29
RESOLVED, That we, the members of the 132nd General	30
Assembly of the State of Ohio, in adopting this resolution, urge	31
the Congress of the United States to enact the Butch Lewis Act	32
of 2017; and be it further	33
RESOLVED, That the Clerk of the Senate transmit duly	34
