BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3301.41 of the Revised Code be	3
enacted to read as follows:	4
Sec. 3301.41. (A) The school safety advisory committee is	5
hereby created. The committee shall review the laws, policies,	6
and practices of other states regarding school safety. When	7
conducting its review, the committee shall focus on all of the	8
following topics:	9
(1) Reduction of harassment, including hazing, bullying,	10
and intimidation, both on and off school grounds;	11
(2) Violence prevention;	12
(3) Mental health of students and staff;	13
(4) Increased parental involvement.	14
(B)(1) The school safety advisory committee shall consist	15
of the following seven members:	16
(a) The governor, or the governor's designee;	17

(b) The superintendent of public instruction, or the	18
<u>superintendent's designee;</u>	19
(c) The director of public safety, or the director's	20
designee;	21
(d) A member representing teachers appointed by the	22
governor;	23
(e) A member representing local law enforcement appointed	24
by the governor;	25
(f) A member of the senate appointed by the president of	26
the senate;	27
(g) A member of the house of representatives appointed by	28
the speaker of the house of representatives.	29
Members shall be appointed under division (B)(1) of this	30
section not later than the first day of March of each odd-	31
numbered year. Initial appointments under division (B)(1) of	32
this section shall be made not later than March 1, 2021.	33
(2) Not later than the first day of April of each odd-	34
numbered year, the school safety advisory committee shall hold	35
its first meeting and select a chairperson from among its	36
members.	37
(3) Members appointed under division (B)(1) of this	38
section shall serve for two years from the date of appointment.	39
(4) If a vacancy occurs prior to the expiration of a	40
member's term, that vacancy shall be filled in the same manner_	41
as the original appointment, and the new member shall serve for	42
the duration of the original member's term.	43
(5) Committee members shall receive no compensation for	44

their service on the school safety advisory committee.		
(C) The department of education shall provide	46	
administrative assistance to the school safety advisory	47	
<u>committee.</u>	48	
(D) Not later than the first day of November of each even-	49	
numbered year, beginning with the even-numbered year that occurs	50	
following the initial appointment of members under division (B)	51	
(1) of this section, the school safety advisory committee shall	52	
submit a report to the general assembly, in accordance with	53	
section 101.68 of the Revised Code, the governor, the	54	
superintendent of public instruction, and the director of public	55	
safety. This report shall suggest improvements to the state's	56	
laws, policies, and practices regarding school safety with the	57	
goal of improving student safety in this state.	58	
Section 2. Section 1 of this act shall take effect on	59	
January 1, 2021.	60
