**A BILL**

To amend section 103.13 and to enact sections 1  
103.132 and 3701.35 of the Revised Code to 2  
require the Legislative Service Commission to 3  
create health impact statements for introduced 4  
bills and to create the Health and Equity 5  
Interagency Team. 6

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 103.13 be amended and sections 7  
103.132 and 3701.35 of the Revised Code be enacted to read as 8  
follows: 9

**Sec. 103.13.** The Ohio legislative service commission 10  
shall: 11

(A) Conduct research, make investigations, and secure 12  
information or data on any subject and make reports thereon to 13  
the general assembly; 14

(B) Ascertain facts and make reports concerning the state 15  
budget, the revenues and expenditures of the state, and of the 16  
organization and functions of the state, its departments, 17

| <b><u>Sec. 103.132.</u></b> (A) <u>As used in this section:</u>   | 55                                     |
| <u>(1) "Health" means the state of a natural person's physical, mental, and social well-being and is not limited to the absence of disease or infirmity.</u>  | 56<br>57<br>58                         |
| <u>(2) "Health disparities" means differences between demographic groups with respect to mortality, the incidence or prevalence of disease or other adverse health conditions, or access to health care services. (B) The general assembly finds that health equity may be 75  
accomplished by removing obstacles to health, such as poverty 76  
and discrimination, and further finds that the consequences of 77  
poverty and discrimination, including unsafe living 78  
environments, general powerlessness, lack of access to good jobs 79  
with fair pay, and poor quality education, housing, 80  
transportation, and health care contribute to health inequity. 81

(C) The staff of the Ohio legislative service commission 82  
shall review each bill introduced in the general assembly on or 83  
after the effective date of this section and prepare a health 84  
impact statement concerning the bill. The health impact 85  
statement shall analyze whether the bill might have a positive, 86  
negative, or neutral impact on any of the following: 87

(1) The health of Ohioans; 88

(2) The accomplishment of health equity in this state; 89

(3) The health or health equity of specific populations or 90  
persons residing in specific geographic areas in this state; 91

(4) The social determinants of health for the most 92  
vulnerable populations in this state. 93

(D) The legislative service commission shall prepare the 94  
health impact statement as soon as possible, but not later than 95  
the date the bill is scheduled for a second hearing in a 96  
committee in the house in which the bill was introduced, or no 97  
later than thirty days after being requested by a member of the 98  
general assembly. 99

(E) A bill shall not be voted out of committee until after 100  
the committee members have received and considered the health 101  
impact statement, unless two-thirds of the members of the 102  
committee in which the bill is pending suspend this requirement. 103
