To amend section 5739.121 of the Revised Code to allow vendors to receive a refund of sales tax remitted for certain bad debts charged off as uncollectible by credit account lenders.

To amend section 4513.612 of the Revised Code to prohibit a towing service from employing or compensating spotters.

H. B. No. 114 - Representatives Skindell, Crawley.

Cosponsors: Representatives Smith, K., Upchurch, Patterson, Howse, Boyd, Kent, Miller, A., Boggs.

To amend sections 5747.71 and 5747.98 of the Revised Code to remove the income restriction on the earned income tax credit and to make the credit refundable.
