INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 322 - Representatives Jones, Manning, D.

To amend sections 3319.111, 3319.22, 3319.223, 3319.227, 3319.229, and 3319.26 of the Revised Code to revise the Ohio Teacher Residency Program.

H. B. No. 323 - Representative Manning, D.

Cosponsor: Representative Seitz.

To amend sections 2925.02, 2925.03, 2925.11, 2925.12, 2925.14, 2925.23, 2925.36, 3701.048, 3715.872, 3719.06, 3719.12, 3719.121, 3719.81, 3795.01, 4723.01, 4729.01, 4729.51, 4731.054, 4731.22, 4732.01, 4732.02, 4732.17, 4732.20, 4732.99, and 5123.47 and to enact sections 4732.40, 4732.401, 4732.41, 4732.411, 4732.42, 4732.43, 4732.431, 4732.44, 4732.45, 4732.46, 4732.50, 4732.501, 4732.502, and 4732.503 of the Revised Code to authorize certain psychologists to prescribe drugs and therapeutic devices as part of the practice of psychology.

H. B. No. 324 - Representative Miller, A.

To amend sections 2307.80, 2315.18, 2315.21, 2323.43, and 3345.40 of the Revised Code to raise the limitations on damages for noneconomic loss and punitive damages in certain tort actions based on adjustments for inflation from the year 2005 to 2019.

To enact section 5.293 of the Revised Code to designate February 18 as "Toni Morrison Day."

H. B. No. 326 - Representative Miller, A.

To amend sections 145.362 and 3309.41 and to enact section 145.364 of the Revised Code to allow a Public Employees Retirement System or School Employees Retirement System disability benefit recipient elected to certain offices to continue receiving a disability benefit during the term of office.

H. B. No. 327 - Representative Patton.

To enact section 4511.515 of the Revised Code to prohibit a business from using an unmanned aerial vehicle to deliver packages.
