### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 439** - Representative Stephens.

Cosponsors: Representatives Hambley, Kick, Koehler, Riedel, Scherer, Crossman.

To amend sections 323.152 and 4503.065 of the Revised Code to adjust for inflation the \$25,000 homestead exemption and the enhanced homestead exemption for disabled veterans.

**H. B. No. 440** - Representatives Miranda, Carruthers.

Cosponsors: Representatives Antani, Cross, Crossman, Manchester, Riedel, Romanchuk, Scherer.

To amend sections 5739.01 and 5739.011 of the Revised Code to authorize sales tax exemptions for property and services used to clean or maintain manufacturing machinery and for employment services used to operate manufacturing machinery.

**H. B. No. 441** - Representatives Plummer, West.

To amend section 4765.16 and to enact sections 109.749 and 4765.162 of the Revised Code to require peace officers and emergency medical service personnel to undergo training on identifying and interacting with individuals with dementia.

**H. B. No. 442** - Representatives Roemer, West.

To amend sections 4701.06 and 4701.17 of the Revised Code to modify the requirements to obtain a certified public accountant certificate.

**H. B. No. 443** - Representatives Plummer, Russo.

To amend sections 1739.05, 1751.01, 1751.92, 3901.83, 3902.30, 3922.01, 3923.51, 3923.87, 3959.20, 4723.94, 4731.2910, 4766.01, and 5168.75; to enact sections 3901.57, 3902.50, 3902.51, 5162.137, and 5167.47; and to repeal sections 3923.27, 3923.28, 3923.281, 3923.282, 3923.29, and 3923.30 of the Revised Code regarding mental health and substance use disorder benefit parity.

Said bills were considered the first time.
